

PHOTOGRAPHY SESSION AGREEMENT — SUNFLOWER MINI SESSION

This agreement is entered into between Casa Octava LLC (the Photographer) and the Client. By booking this session through the Casa Octava online booking page, the Client agrees to the following terms and conditions:

- **Session Fee:** The total fee for the 15-minute mini session is \$180.
- **Deposit:** A non-refundable 50% deposit (\$90) is required to reserve the session. The remaining balance of \$90 must be paid before the session begins. The booking is not confirmed until the deposit is received and this agreement is accepted.
- **Delivery:** The session includes 10 professionally edited digital photographs delivered through an online gallery.
- **Selection Gallery:** At its discretion, Casa Octava may apply its standard editing to additional photographs and display them in the gallery so the Client may make a selection and, if desired, purchase additional images. The presence of additional photographs in the gallery does not mean they are included in the session fee.
- **Additional Photographs:** The Client may purchase additional photographs or the full gallery directly through the online gallery at the prices displayed there.
- **Included Editing:** Casa Octava's standard editing may include adjustments to exposure, white balance, color, contrast, cropping, and natural corrections or softening according to the Photographer's judgment and artistic style. Editing is intended to preserve a natural appearance and the identity of the person photographed.
- **Advanced Retouching:** Advanced retouching is not included. Requests requiring detailed work or specific modifications—such as extensive reduction or removal of expression lines, facial or body alterations, detailed skin retouching, complex changes to hair, makeup or clothing, or removal of elements—may be quoted separately based on complexity and the number of photographs.
- **Editing Style:** By hiring Casa Octava, the Client acknowledges its photographic and editing style. Reasonable adjustments within the standard edit may be considered; requests for a different style or a higher level of retouching may require an additional quote.
- **Cancellation and No-Rescheduling Policy:** The deposit is non-refundable, and the session cannot be rescheduled. Cancellations must be made at least 72 hours in advance. If the Client cancels less than 72 hours before the session or fails to attend,

the full session fee of \$180 will be charged.

- **Weather Clause:** If severe weather, closure of the field, or another circumstance beyond Casa Octava's control prevents the session from taking place, it will be rescheduled based on availability. Payments will transfer to the new date, but identical blooms or natural conditions cannot be guaranteed.
- **Punctuality Policy:** The session will begin and end at the reserved time regardless of the Client's arrival time. Late arrival reduces the available session time and does not extend the session. If insufficient time remains, any new session will be subject to availability and will require full payment for another mini session.
- **Cooperation and Minors:** The Client is responsible for the preparation, cooperation, and supervision of all participants, especially minors. Casa Octava does not guarantee specific smiles, expressions, or poses when a participant does not cooperate; this does not entitle the Client to a refund or complimentary reshoot.
- **Turnaround Time:** Edited photographs will be delivered approximately 2 to 3 weeks after the Client completes the selection.
- **RAW Files:** RAW files, unedited photographs, duplicates, test shots, rejected images, and all images captured during the session are not delivered.
- **Usage Rights:** Casa Octava retains the copyright to all images. The Client receives personal-use rights and may print and share the final photographs on social media. Casa Octava may use the images for portfolio and promotional purposes unless otherwise agreed in writing.
- **Download and Archiving:** The Client must download and back up the final photographs within 30 days of delivery. Casa Octava does not guarantee indefinite gallery hosting or permanent file storage.
